

## BOAT STORAGE AGREEMENT

## **Terms of Agreement**

- 1. From date of Agreement until removal of boat from DSC premises.
- 2. The club agrees to allow the member to store the boat and reasonable rigging on the club premises upon payment of the annual storage fee.
- 3. The storage fee is payable at the beginning of the Summer sailing season, that is the 1st of September each year or when the boat is stored at the club for the first time. The storage fee is not transferable and not refundable if the boat is sold or removed from the Club premises before the end of the financial year unless the Sailing Manager or Sailing Committee approve such refund or transfer.
- 4. The Sailing Manager and Sailing Committee reserves the right to review all boat storage agreements and may terminate the storage agreement and remove the boat from the Club premises if the boat has not raced:
  - a. regularly in the club season;
  - b. on at least five race days between the start of the season and 31 December.

The Club racing season begins in September and concludes in April the following year. If the boat remains at the Club after 1 September the member agrees to pay the annual storage fee for the boat and to be bound by these terms and conditions. The Sailing Committee and Class Committees set the annual storage fee. A schedule of fees can be obtained on the Club Website or from the Club Sailing Office.

- 5. The Club will not be liable for any loss or damage to boat or fittings while stored at the Club or elsewhere.
- 6. If the storage fee is unpaid for more than 2 months, then the club is authorised to sell or otherwise

dispose of the boat and deduct from the proceeds any storage fees and any costs associated with removal, storage and sale of the boat and fittings.

- 7. Any sale pursuant to this clause may be affected by the Club offering the goods for sale by private treaty by advertising with a notice on the DSC Notice Board located in the Club's Sailors' Lounge. Once such notice has been displayed, the Club is at liberty to sell the goods for the highest offer received within a minimum of 14 days of the notice appearing. If no offer is received within 14 days of the notice appearing, then the Club may dispose of the goods in any manner it sees fit.
- 8. Payment of storage fees entitles the member to occupy only one storage space per boat/craft as directed by the Sailing Manager and Sailing Committee. Road trailers or launching dollies must be kept in the space allocated, or stored away from the Club. Any trailers or dollies left on club premises and not in the allocated space will be removed and left outside the Club premises and the Club will not be liable for any loss or damage as a result.
- 9. The boat and any rigging left on the Club premises must be clearly marked to allow easy identification.
- 10. Members should advise the Sailing Office if other persons (only DSC members) are authorised to use their boat or rigging.
- 11. The terms of the agreement may be altered from time to time by the Sailing Committee and will become effective once notified on the Club Notice Board in the Club's Sailors' Lounge. If a member does not accept the amended terms as notified, they will remove their boat and rigging from the Club within 7 days (and notify the Sailing Committee in writing).
